The Chairman of the Committee provided a comprehensive update to all the participants regarding the current status of the ongoing tender process. The purpose of this process is to facilitate the hiring and selection of a qualified consultant responsible for the design, documentation, and project supervision of the digitalization of the Sindh Public Service Commission Recruitment Management System.

Initially the following firms participated and filed Tender Documents (Technical & Financial) upto the closing date and time viz 08.06.2023 @ 03:00 p.m.

The Committee examined / scrutinized the required / relevant documents produced in sealed Technical Envelopes by the bidders and as per Technical Criteria the bids submitted by **(1) M/s Oclits Pvt. Ltd (2) M/s Inbox Business Technologies Ltd & (3) M/s Socio Engineering Consultant Pvt. Ltd & C World Technologies** were disqualified on the grounds, as such their bids were deemed ineligible and disqualified based on the scrutiny criteria specified in the Request for Proposal (RFP) document for the submitted documents by the bidders. They were advised to receive their financial proposal/envelopes.

Furthermore, M/s K Compute, Karachi in the first round of scrutiny has preliminarily met the initial eligibility criteria specified in the Tender Documents. However, it was decided that the detailed evaluation would be carried out once the firm gives its presentation and answers the queries, if any, raised by the members of the procurement committee.

After careful consideration and thorough deliberations, following detailed presentations from Ms. KCompute for the second round, the decision has been reached unanimously to grant the tender to the esteemed firm M/s KCompute. This selection is primarily based on their technical expertise and financial suitability, which aligns with the requirements outlined in the tender.
