COMBINED COMPETITIVE EXAMINATION (CCE-2026)

(APPLY ONLINE WELL BEFORE 23-09-2026)

1. The allocation of posts will be made according to the number of posts available in different departments and subject to the order of options exercised by the candidates.
2. Only Online applications will be accepted. Manual application forms shall not be entertained.
3. **ELIGIBILITY:**
 - (i) Both male & female including Minority and differently abled persons, who are citizens of Pakistan.
 - (ii) Domiciled and permanent resident of Sindh Province as on **23-09-2026** are eligible.
 - (iii) Candidates having atleast 2nd Division Bachelor's degree are eligible.
 - (iv) Candidates possessing foreign degrees shall have obtained an HEC Equivalence Certificate before the closing date and uploaded on online portal in the qualification section (relevant field). As a one-time facilitation during the initial introduction of the document management system on online portal at least 10 days before the commencement of screening test.
 - (v) Candidates between 21 to 30 years of age as on **01st September, 2026**, are eligible.
 - (vi) In case of candidates domiciled in Sindh Province who are serving in the Federal Govt. / Sindh Government with a total continuous regular service of at least four years as on **01st September, 2026**, the upper age limit shall be **35 years**.

NOTE:

1. **Employees of Autonomous / Semi-Autonomous / Local Bodies / Adhoc / Contract are not eligible for concession mentioned in 3 (vi) above.**
2. **In Compliance to order of Honorable Supreme Court of Pakistan in Suo Moto Case No. 18/2016 dated 13.03.2017, the CCE has been regularized on annual basis, the condition of three attempts has been applied effective from CCE-2019.**
4. **Rules, revised syllabus and recommended books could be seen on SPSC website (www.spsc.gov.pk).**
5. **QUOTA FOR FEMALE, MINORITIES AND DIFFERENTLY ABLED PERSONS.**

7. **CANDIDATES ARE ADVISED TO READ FOLLOWING INSTRUCTIONS CAREFULLY:-**
 - (i) SPSC has implemented an online fee submission process. Candidates shall generate a PSID before making the Challan payment of Rs. 1000/- through any online payment channel by selecting the 1 Bill invoice/Service option.
 - (ii) Fill in the Online Form and check it carefully before submission on or before **23.09.2026**.
 - (iii) Choose the optional subjects correctly and in accordance with the prescribed **Syllabus**.
 - (iv) **Domicile, PRC-Form-D, Urban or Rural quota, Age, Qualification, Examination Centre and Optional Subjects once exercised shall not be changed after the closing date.**
 - (v) **If any candidate fails to appear in any one paper he/she will not be allowed to appear in subsequent papers.**
 - (vi) Enter correct CNIC Number & Date of Birth in Online Form. Wrong entry shall lead to rejection of candidature.

NOTE:

- I. In light of the amendment made to Regulation 74, Sub-regulation (2), Clause (iii) of RMR-2023, the qualifying criteria for the screening test of the CCE have been amended as follows:
33 Percent marks (66 marks) shall be substituted with 40 percent marks (80 marks).

II. Candidates with permanent disabilities who require any special assistance during the Written Examination/Test shall inform the Sindh Public Service Commission (SPSC) at least seven (07) days prior to the commencement of the examination. Such candidates shall submit a written application to the Controller Examination in accordance with Regulation 58(A) of the RMR, 2023 with a copy to PS to Chairperson, SPSC alongwith attested copy of disability certificate issued by the Competent Authority(Department of Empowerment of Persons with Disabilities-DEPD), Government of Sindh, and special CNIC for disabled persons issued by NADRA. In addition to that the candidate shall be bound to produce original valid disability certificate along with the aforesaid CNIC issued by NADRA to the In-charge of Examination Center on the day of the examination or else no assistance shall be provided.
