OFFICE ORDER:

WHEREAS, it was alleged by the Senior Supervisor at Public School Hyderabad, that during the written examination for the post of Medical Officer (BPS-17), a candidate Mr. Kabir s/o Mevaram having Roll No. 326672 had intentionally torn apart / damaged his question paper, and answer copy. For which he was also issued show cause notice.

WHEREAS, he submitted the reply of the notice in which he categorically admitted his blunder by stating that due to anxiety and mental distress he had committed such act and deeply remorseful for his wrongdoing.

WHEREAS, an enquiry was initiated against him by Mr. Rizwan Ahmed, Member. In the spirit of justice and fair play, Dr. Kabir was called for personal Hearing on 12.06.2025. During personal hearing he admitted that he is responsible for his misconduct and reaction showed during the examination.

AND WHEREAS, learned Member Mr. Rizwan Ahmed after perusal of the record recommended that Dr. Kabir S/o Mevaram (CNIC No. 44303-5488271-1) is found guilty of violating the provisions of Regulation 157(h) of the Sindh Public Service Commission (Recruitment Management) Regulations, 2023 and therefore, recommended to impose penalty of disqualification of 2 years from contesting in any SPSC exam in pursuance of Regulation 45 (1) of the Regulations *ibid*.

NOW, THEREFORE, Dr. Kabir s/o Mevaram, a candidate for the post of Medical Officer (BPS-17) Roll No. 326672, having been found guilty of violating the provisions of Regulation 157 (h) of the Regulations *ibid* and in exercise of powers conferred under Regulation 160 (ii) of the Sindh Public Service Commission (Recruitment Management) Regulations, 2023 is hereby declared **disqualified for a period of 02 years to contest in any SPSC exams** as provided in Regulation 45 (1) of the Sindh Public Service Commission (Recruitment Management) Regulations, 2023.
