Notification

The following Departmental Examination for (Session November/December, 2024) will be held during the month of February, 2025 at Hyderabad.

1. Revenue Qualifying Departmental Examination (R.Q.E)

- O1. The Examination will be held on the basis of the syllabus and the rules applicable for the present Examination read with the Sindh Civil Servants (Departmental Examinations) Rules 1978 in light of Standing Orders of Board of Revenue, Sindh and as per Sindh Public Service Commission (Functions) Rules, 2022.
- O2. The eligible candidates may send their particulars on the prescribed proforma through their <u>Appointing Authority</u>, along-with a challan of Rs: 500 (Rupees five hundred only) duly paid under the Head of Account "C02101 Organ of state Examination Fees (Sindh Public Service Commission) Receipt" (in original) should also be along with the application form. The Prescribed Proforma, duly countersigned by the Competent Authority, may reach Sindh Public Service Commission Head Office not later than <u>13-12-2024 (Friday)</u>. The candidates whose particulars are not received from the concerned Administrative Department on or before closing date or they failed to enclose required Challan of Examination fees duly paid in the correct Head of Accounts, <u>shall not be</u> admitted to the Examination.
- 03. The number of attempts made by the candidate previously with result and Roll No. should clearly be indicated in prescribed proforma elsewhere their <u>application will not be entertained.</u>
- O4. The candidates, who could not secure at least 35% marks in previous attempts of Revenue Qualifying Examination will not be considered as eligible candidates as per Standing Orders of Board of Revenue, Sindh at Note 08-A at Page No. 290 and as per Orders of Honorable Sindh High Court, Circuit Bench, Hyderabad dated:06.01.2021 in C.P No. D-1481/2020 filled by Mr. Sajad Ahmed Bughio v/s Province of Sindh, the Order is re-produced as "Eligibility of officials of Board of Revenue Sindh for Revenue Qualifying Examination the eligibility criteria fixed in Standing Order No. 11 Section-E of Revenue Department Sindh shall be Strictly followed and no deviation for so ever shall occur in all future times".
- 05. Moreover, the Honorable High Court of Sindh, Sukkur Bench has Ordered on. 15.10.2024 in C.P No. D-1181 of 2023 filed by Mr. Farhan Ali Shaikh the operative Para No.11 of the Order is reproduced as; "In light of the above discussion, the petition is allowed. The respondents are directed to consider the Petitioner as a <u>special case</u> under the current policy and permit him to appear in the RQE. Additionally, it is expected that future developments will align with the

observations made herein. Let a copy of this order be sent to the Secretary to Government of Sindh. Revenue Department through learned Additional Advocate General Sindh for information and compliance".

06. If a candidate, admitted in the Examination is unable to appear for any reason, he should send such intimation to the Additional Controller of Examinations, Sindh Public Service Commission, Hyderabad at least 07 days before the date of commencement of Examination.

07. NO APPLICATION SHALL BE ENTERTAINED IF RECEIVED AFTER THE EXPIRY OF CLOSING DATE i.e. 13-12-2024 (Friday).
