- 2. The Examinations will be subject to the syllabus and the rules applicable read with the Sindh Civil Servants (Departmental Examinations) Rules 1978 in light of Standing Orders of Board of Revenue, Sindh and as per Sindh Public Service Commission (Functions) Rules, 2022.
- 3. The candidates may send their particulars on the prescribed proforma through their **Appointing Authority**, along-with a challan of Rs: 500 (Rupees five hundred only) duly paid under the Head of Account "C02101 - Organ of state Examination Fees (Sindh Public Service Commission) Receipt" (in original). The Prescribed Proforma, duly countersigned by the Competent Authority, may reach Sindh Public Service Commission Head Office not later than 25-10-2024(Friday). The candidates whose particulars are not received from the concerned Administrative Department on or before closing date or they failed to enclose required Challan of Examination fees duly paid in the correct Head of Accounts, shall not be admitted to the Examination.
- If the Departmental Examinations contains two parts, separate Examination Fees of Rs: 500/- (Rupees Five Hundred only) is to be paid for each part of the said Departmental Examination. The prior special permission for appearing in both parts of Examinations, simultaneously, is essential for admission in the second part.
- The number of attempts made by the candidate previously with result 5. thereof should clearly be indicated elsewhere their application will not be entertained.
- If a candidate, admitted in the Examination is unable to appear for any reason, he should send such intimation to the Additional Controller of Examinations, Sindh Public Service Commission, Hyderabad at least 07 days before the date of commencement of Examinations.
- NO APPLICATION SHALL BE ENTERTAINED IF RECEIVED AFTER 7. THE EXPIRY OF CLOSING DATE i.e. 25-10-2024(Friday).
