PRESS RELEASE

Sindh Public Service Commission conducted assessment of eligibility and competence of IBA Selected Head Master/ Head Mistress (BPS-17) in School Education & Literacy Department, Government of Sindh through scrutiny of documents and interviews and result was announced vide press Release No. PSC/EXAM (S.S)/2023/307 dated 25.07.2023. Consequent to the appeals filed by the candidates who were not recommended for regularization, SPSC reviewed eligibility and competence of candidates. Who prima facie fulfilled at least one out of the three combinations of academic qualifications and teaching experience as provided in the recruitment Rules 2021 of School Education & Literacy Department for the post of Head Master/ Head Mistress of (BPS-17) and found following candidates fit and suitable in order of merit for regularization of their services. - 01. It is provided in the Recruitment Rules 2021 for the post of Head Master / Head Mistress (BPS-17) that, inter alia, the teaching experience should be of serving as a teacher in Government / Government 17) that, inter alia, the teaching experience should be of serving as a teacher in Government / Government 17) that, inter alia, the teaching experience should be of serving as a teacher in Government / Government of Regulated Institutions for a given period of time as prescribed therein with each combination of qualifications. The Committee did not have the required information or wherewithal to verify whether these Schools / Institutions were duly registered with the Directorate General of Private Institutions, School Education & Literacy Department to Candidates. Therefore, the Committee recommends to ask the School Education & Literacy Department to verify valid registration of the private schools / Institutions throughout the period which has been claimed by the candidate to be the period of his/her teaching experience at the time of submission of application. The determination of eligibility and competence by the Committee shall be subject to verification and validity of the experience certificate by the Administrative Department. If the School Education & Literacy Department finds that the concerned school was not registered, and in such case, if the experience falls short of the required length, then the Candidate shall be rendered ineligible.
- O2. As per the Policy of School Education & Literacy Department reflected in the original advertisement for appointment as contractual Head Master / Mistress, the Department had put conditions of district-based appointment, and the post being non-transferable. Accordingly, the Committee has prepared merit list in descending order on the basis of the district of domicile. The candidates who had secured the same marks in interview has been assigned merit on the basis of their age (older to be ranked higher).
- 03. Those candidates who have secured less than 33 marks out of a total of 100 marks have been declared "Incompetent", and not recommended.

- 1. <u>Publication of the above result does not entitle the candidate to be appointed to the post as a matter of right.</u>
- 2. The Commission reserves the Right to modify / correct the result at any stage if any error is detected later on.
